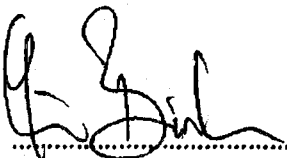

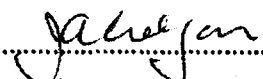

SUNDAY 3RD DECEMBER 2017

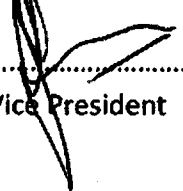
1. IT WAS RESOLVED that Rule 13 (a) of the Franklin Bridge Club Inc. Rules is amended to read:
